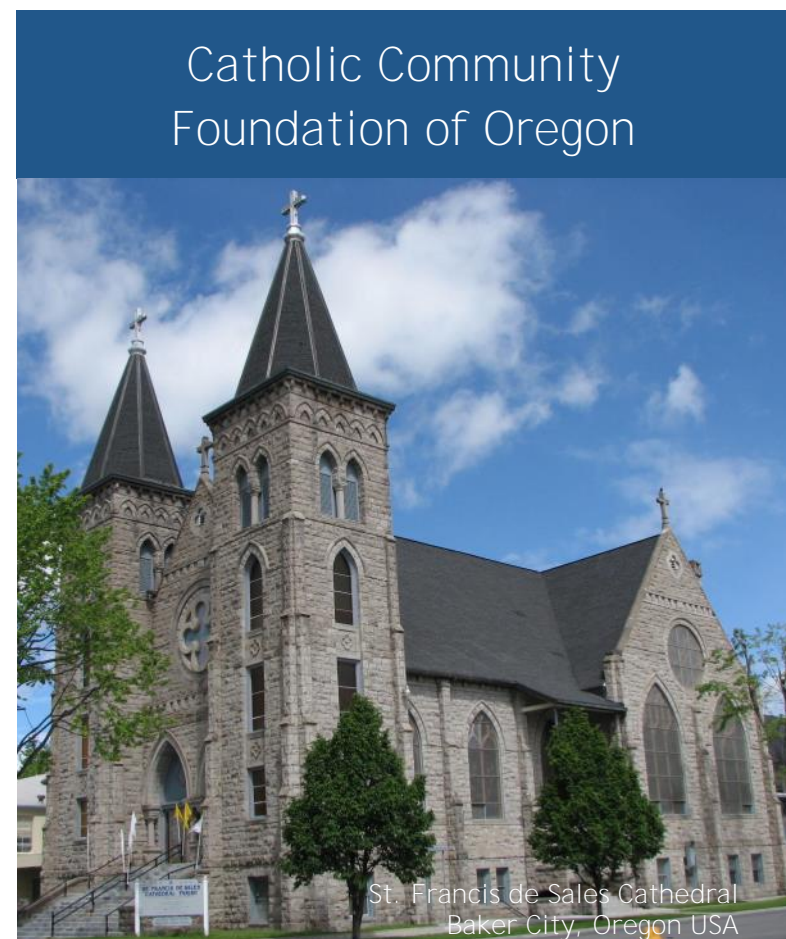

Types of Funds

Designated Funds

Designated funds are established by donors to benefit one or more specific organizations.

Sustaining Administrative Endowment Fund

A donor may also wish to provide administrative support to the endowment fund established for The Legacy of Faith Catholic Community Foundation of Oregon.

Donor Advised Funds

Donors can establish a fund that enables them to choose their distributions from the fund. This provides the donor considerable flexibility.

Scholarship Funds

A donor may establish a Scholarship Fund to benefit students seeking education in Catholic schools at the elementary, middle school, high school or university level.

Special Project & Building Funds

Special projects can be for the improvement of identified programs within individual parishes. Building funds would be for the construction of permanent facilities.

Field-of-Interest Funds

A donor may direct that a gift be used to support a particular or general charitable interest, such as children, health, senior citizens, etc.

Discretionary Funds

A donor may choose to make a gift toward the broad general charitable purposes of the Foundation.
